Introduction

Accountancy and finance hiring in North America, broadly speaking has returned to pre-pandemic levels.

The finance recruitment market in the past three years has gone through a turbulent time. If we say 2023 was a year of poor forecasting, 2024 has been a year of recalibration. This equilibrium is a welcome change.

Emerging locations for finance and accountancy professionals

Despite the lingering economic uncertainty, which is a side effect from the global year of elections and macro-economic trends, recruitment has been strong and steady. Specifically, the cities of Boston, MA and Austin, TX have experienced growth over the past twelve months. Boston is emerging as a powerhouse, mainly because it is a known incubator for companies spinning out from local universities and good transportation links to other US cities. Conversely Austin benefits from Texas' business-friendly climate, with no corporate or personal income tax, a highly skilled and diverse workforce, robust infrastructure, and sensible regulatory environment.

Defence and financial services are ones to watch for 2025

In terms of industries which are growing, we are seeing a massive increase in the number of finance professionals being hired into defence and space manufacturing. This finding is supported by LinkedIn, which notes that there has been a 93% increase in this talent pool within the industry. Moreover, financial services appear to have experienced a strong rebound across all verticals which is a positive marker for what is to come in 2025.

Candidate expectations

We have also seen a levelling out in candidate expectations. Post-pandemic, the ability to work from home was a deciding factor for many professionals looking to change roles. And in some cases, more important than compensation packages.

To put it simply, people simply didn't want to return to the office five days a week. In cases where businesses mandated five days a week in the office, they were met with resistance. However, over the course of the past eighteen months, there has been a definite shift with people being more open-minded about working in the office. Ultimately, as long as people are able to work flexibly as life happens, they are happy . But as we said last year, the expectations around flexible and remote working are highly complex and an ever-evolving paradigm.

What to look out for in 2025




